

2016-2017 V-4 Custom Verification Worksheet

Your 2016–2017 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before awarding Federal Student Aid, ESCC is required to ask you to confirm the information you and your parents reported on your FAFSA. To verify that you provided correct information, ESCC Financial Aid administrators will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the ESCC Financial Aid Office. ESCC may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid awards will not be delayed.

B. High School Completion Status

A. Student's Information

Provide <u>one</u> of the following documents that indicate the student's high school completion status when the student will begin college in 2016–2017:

- A copy of the student's high school diploma.
- A copy of the student's final official high school transcript that shows the date when the diploma was awarded.
- A copy of the student's General Educational Development (GED) certificate or GED transcript.
- An academic transcript that indicates the student successfully completed at least a two-year program that is acceptable for full credit toward a bachelor's degree.
- If State law requires a homeschooled student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a copy of that credential.
- If State law does not require a homeschooled student to obtain a secondary school completion credential for homeschool (other than a high school diploma or its recognized equivalent), a transcript or the equivalent, signed by the student's parent or guardian, that lists the secondary school courses the student completed and documents the successful completion of a secondary school education in a homeschool setting.

If the student is unable to obtain the documentation listed above, he or she must contact the financial aid office.

C. Identity and Statement of Educational Purpose (To Be Signed at ESCC)

The student signing below must appear in person at Enterprise State Community College to verify his or her identity by presenting valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. ESCC will maintain a copy of the student's photo ID annotated with the date it was received and the name of the official at the institution authorized to collect the student's ID.
